# Organization Chart

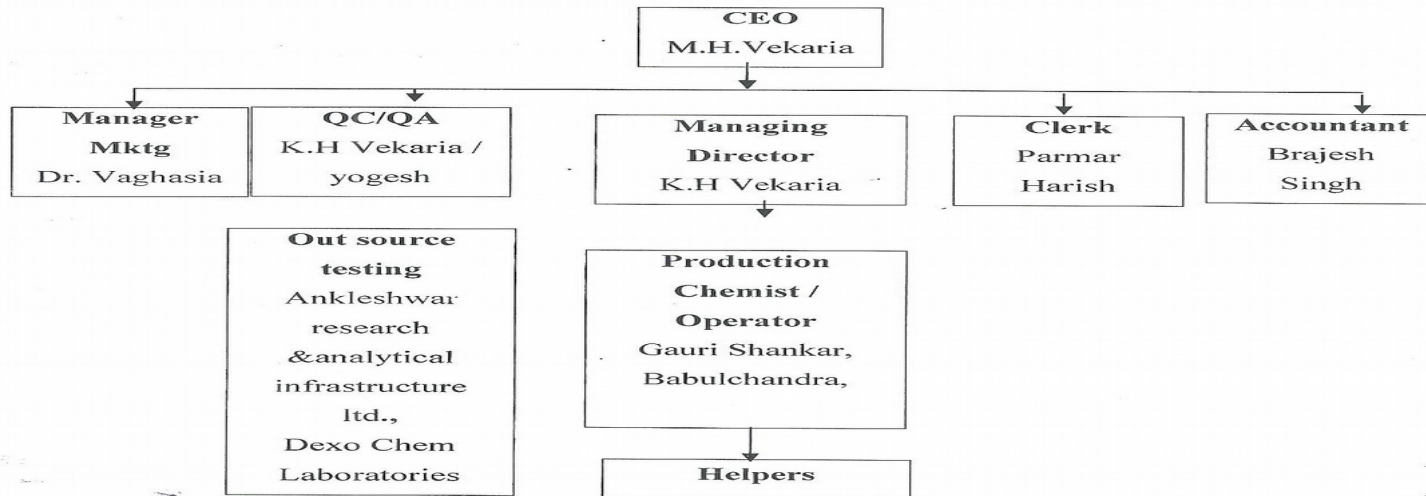

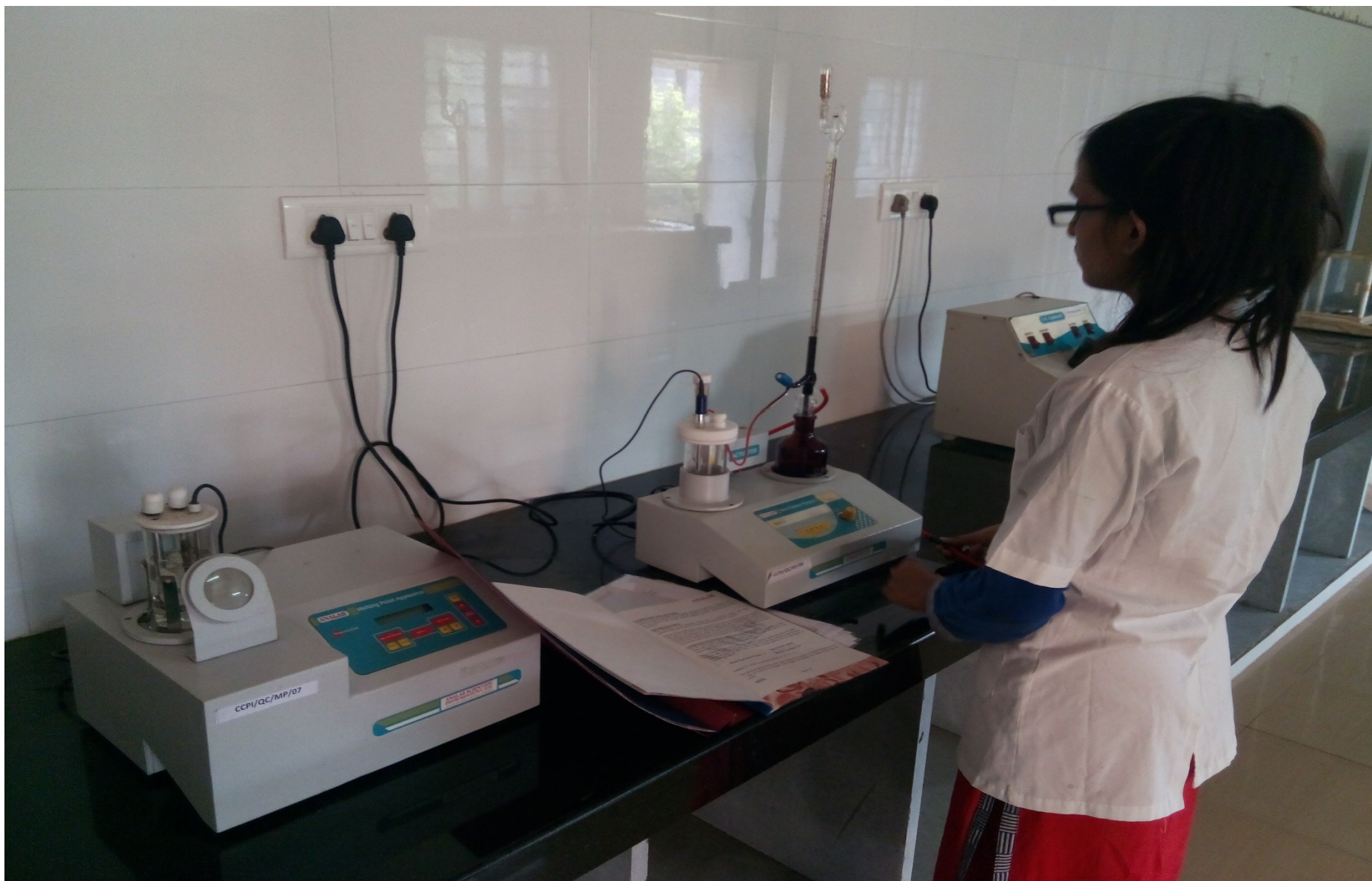

# PLANT LAYOUT

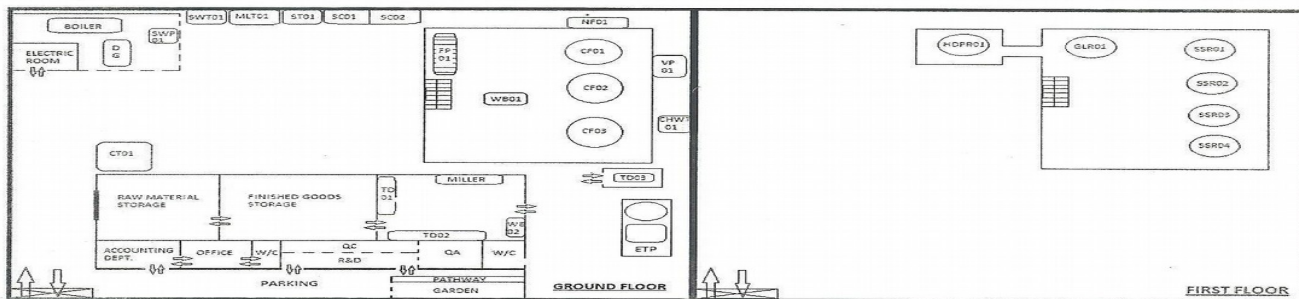
