Dear Sir / Madam,

Sub: Corporate Insolvency Resolution Process under Insolvency & Bankruptcy Code, 2016, (hereinafter referred to as "Code") against M/s Dunar Foods Limited (Corporate debtor),

- Control and Custody of all Trademarks registered in the name of the "Dunar Foods Limited"
- 1. The Hon'ble Adjudicating Authority, i.e., National Company Law Tribunal, Mumbai Bench was pleased to admit the Company Petition i.e. C.P. NO. 1138/I&BC/NCLT/MB/MAH/2017 on 22.12.2017, filed by the financial creditor, State Bank of India, initiating Corporate Insolvency Resolution Process under Insolvency & Bankruptcy Code, 2016 (hereinafter referred to as "Code") against M/s Dunar Foods Limited (Corporate debtor). The Adjudicating Authority has also appointed the undersigned as Interim Resolution Professional (IRP) vide its order dated 22.12.2017 (Copy of the order and subsequent public announcement copy attached)
- 2. The Committee of creditors, constituted under the provisions of the code, had its first meeting on 02.02.2018 and resolved to appoint undersigned as Resolution professional.
- 3. In terms of provision of the code, on admission of petition in NCLT, the powers of board of directors have got suspended and management is vested with the undersigned, being interim resolution professional. Further Section 23 of the code provides that *"The resolution professional shall exercise powers and perform duties as are vested or conferred on the interim resolution professional under this chapter"*
- 4. Section 18(1) of the code lays down the provisions for the duties of the interim resolution professional which is reproduced herein below-

Section 18 - The interim resolution professional shall perform the following duties, namely:— (f) take control and custody of any asset over which the corporate debtor has ownership rights as recorded in the balance sheet of the corporate debtor, or with information utility or the depository of securities or any other registry that records the ownership of assets including—

(i) assets over which the corporate debtor has ownership rights which may be located in a foreign country;

(ii) assets that may or may not be in possession of the corporate debtor; (iii) tangible assets, whether movable or immovable;

(iv) intangible assets including intellectual property;

(vi) assets subject to the determination of ownership by a court or authority;
