Our country India is a member country following the ISPM15 Regulations for the wooden packaging material for the import and exports. We have a query about the COMPRESSED WOOD PALLET, also popularly known as PRESSWOOD PALLET. As per the ISPM15 Standards 2.1 clause for the Exemption (for wooden packaging material), any wooden packaging material of particles less than 6mm and material is bonded with adhesive and treated with heat and pressure at the same time and is just similar to any other processed wood such as particle board, it is not required to be further heat treated and fumigated. We have attached a copy of the ISPM15 Regulations copy along with this email for your reference. So, we have a query that for these kind of pallets i.e. Compressed Wood Pallets that : Is there any certification or marking required just in case of traditional wooden pallets for the purpose of export to U.S.? We have attached a picture of the Compressed Wood Pallet for your reference along with this email. Please refer the attached file.
