

TERMS AND CONDITIONS

Most important: Order once placed with us cannot be revoked without our written consent. In such cases you have to bear a minimum expense Rs. 500.00, as order cancellation charges. Plus the expenses paid by us on it. Such as expenses for procuring of the goods, advance paid by us to supplier etc. and bank charges for refund, if any, etc. (Please Place order very carefully confirming rates, sizes, quality etc.etc.)
ASK FINAL RATES BEFORE PLACING YOUR ORDERS.

IN CASE OF FOREIGN BUYERS: If amount of refund is less than or equal to bank charges, the amount will not be returned, the amount will remain as credit with us, (VERY IMPORTANT "WITHOUT INTEREST"), and will be adjusted in your next purchase. (MINOR AMOUNTS LESS THEN OR EQUAL TO RS 1000.00 WILL NOT BE REFUNDED.)

If buyer wants insurance of goods, get it on your end, at present we do not have any system of getting it insured. In future, if possible at our end, we will get it insure, at your cost.

We reserve the right to supply goods or not, even accepted by us or partly supplied, by us. (As rates can change any moment of time, without prior notice. Or for any other unavoidable circumstances.)

FOUR CATEGORIES FOR COUSTOMERS are as follows:

1. **INDIAN CONSUMERS ONLY , NO FOREIGN CONSUMER: Have to pay 100% as advance.** The goods can be supplied within 1 working day to 7 working days maximum. If not supplied we can ask or you can ask for extension of time (depending the supply position of goods). If order is revoked by us in writing, you will get back **your deposit - expenses mentioned as above**, with us within 7 working days, of letter of revoking of order from

our side. If not paid by us, after 7 working days of letter for revoking the order from over side, **your deposit - expenses as mentioned as above**, will earn a **lowest interest** of FDR form any nationalised bank in India, for 1 yr (i.e. about 7.5% P. A. at present).

2. **Retailers Indian / foreign : Have to pay 50% - 75% % (depending upon the item and quantity of order) as advance and balance before dispatch.** The goods can be supplied within 1 working day to 15 working days maximum. If not supplied we can ask or you can ask for extension of time (depending the supply position of goods). If order is revoked by us in writing, you will get back **your deposit - expenses mentioned as above**, with us within 15 working days , of letter of revoking of order from our side. If not paid by us, after 15 working days of letter for revoking the order from over side, **your deposit - expenses as mentioned as above**, will earn a **lowest interest** of FDR form any nationalised bank in India, for 1 yr (i.e. about 7.5% P.A. at present).
3. **Wholesalers Indian/ foreign: Have to pay 50% -75% (depending upon the item and quantity of order) as advance and balance before dispatch.** The goods can be supplied within 1 working day to 15 working days maximum. If not supplied we can ask or you can ask for extension of time (depending the supply position of goods). If order is revoked by us in writing, you will get back **your deposits - expenses mentioned as above**, with us within 7 working days, of letter of revoking of order from our side. If not paid by us, after 7 working days of letter for revoking the order from over side, **your deposit - expenses as mentioned as above**, will earn a **lowest interest** of FDR form any nationalised bank in India, for 1 yr (i.e. about 7 .5% P.A. at present).
4. **Manufacturers Indian/ foreign: Have to pay 50% -75% (depending upon item and quantity of order) as advance and balance before dispatch.** The goods can be supplied within 1 working day to 15 working days maximum. If not supplied we can ask or you can ask for extension of time (depending the supply position of goods). If order is revoked by us in writing, you will get back **your deposits - expenses mentioned as above**, with us within 7 working days, of letter of revoking of order from our side. If not paid by us, after 7 working days of letter for revoking the order from over side, **your deposit - expenses as mentioned as above**, will earn a **lowest interest** of FDR form any nationalised bank in India, for 1 yr (i.e. about 7 .5% P.A. at present)

FOR INDIAN BUYERS ONLY: WE CAN ONLY HELP YOU TO GET THE GOODS REPLACED FROM CONCEREND MAUFECTURES, AT YOUR COST OF TIME AND MONEY ETC. THIS IS FOR INDIAN BUYERS ONLY, NOT FOR FORIGEN BUYERS (BECAUSE THE COST IS MORE THEN THE VALUE OF THE GOODS IN THIS CASE).

8. **All payments through our bankers only.**
