

3. Operator is requested to submit GMO test, Pesticides & Residue analysis report to INDOCERT for every organic export
4. Before every organic export operator should obtain Provisional Transaction Certificate and also should obtain Final Transaction Certificate within 30 days from the date of provisional TC for complying with NPOP
