### DIRECTIONS FOR USE

#### AS A BONDING AGENT

- Dilute Perma Bond with water in the proportion of 1:1 and brush apply on the concrete or plaster surface with the help of a brush.
- Within 10 minutes of this application apply a dash plaster with cement and coarse sand to a minimum thickness.
- Wait for 24 hours and apply regular plaster.

#### AS AN ADMIXTURE IN REPAIR SCREEDS AND MORTARS:

Mix for light duty screeds and repair mortars

- Cement 50 kg
- Zone II sand 150 kg
- Bond 10 Litres

For heavy duty screeds and Industrial floor repair

- Cement 50 kg
- Zone II sand 75 kg
- 10 mm down granite aggregate 75 kg
- Bond 15 Litres

Neat 6-12 m<sup>2</sup>/Litre 1:1 Diluted with water 16-20 m<sup>2</sup>
