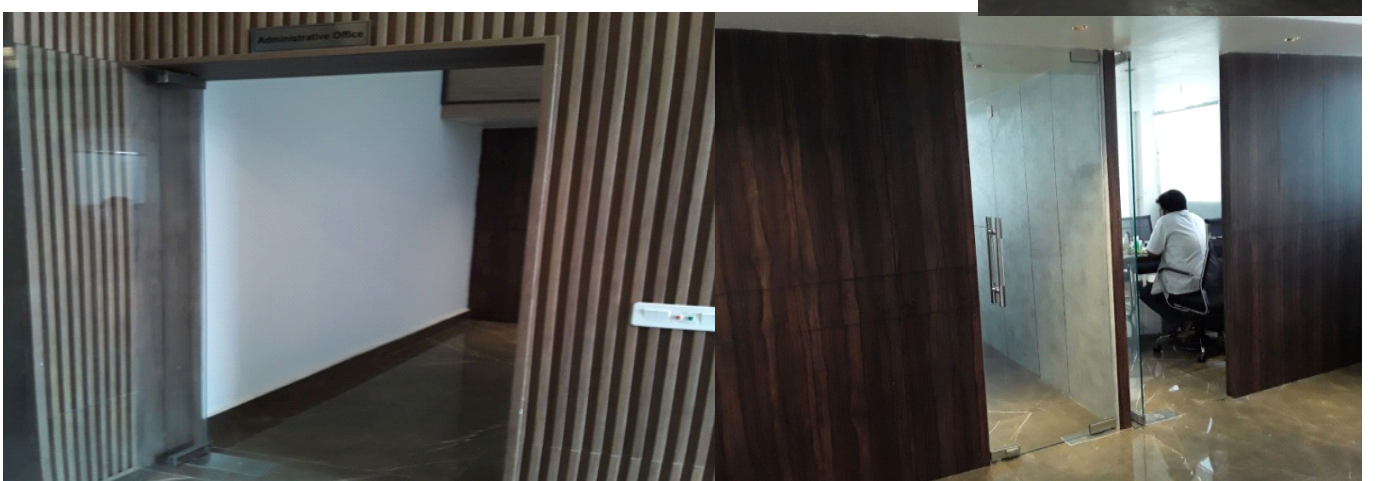
CONTEMPORARY CONCEPTS OF QUALITY CRITERIA

During ancient times, drugs were prepared by the physician himself to cater the needs of his patients in small batches. Over the centuries, these practices were changed and resulted in large scale manufacturing and wide distribution of Ayurvedic drugs at National and International levels. This commercialization should always ensure quality of the products using proper standardization parameters. Contemporary approaches consider Certain specifications that are required in defining the quality of a product. They can be categorized as below:

I. Clear scientific definition: Quality aspects start from clear scientific definition of raw material. exact species, part of the plant used, origin of the plant, time of collection or harvesting, drying procedures should be specified.

II. Purity: Relevant analytical parameters like moisture content, ash values, extractive values, microbial contamination, heavy metals, pesticide residues, aflatoxins etc. Will help in evaluating the quality of herbal raw material.





STORE ROOM MANAGEMENT - We maintain proper storage of raw materials and of finished goods is not only essential to prevent physical losses, but is also an important aspect of quality control.

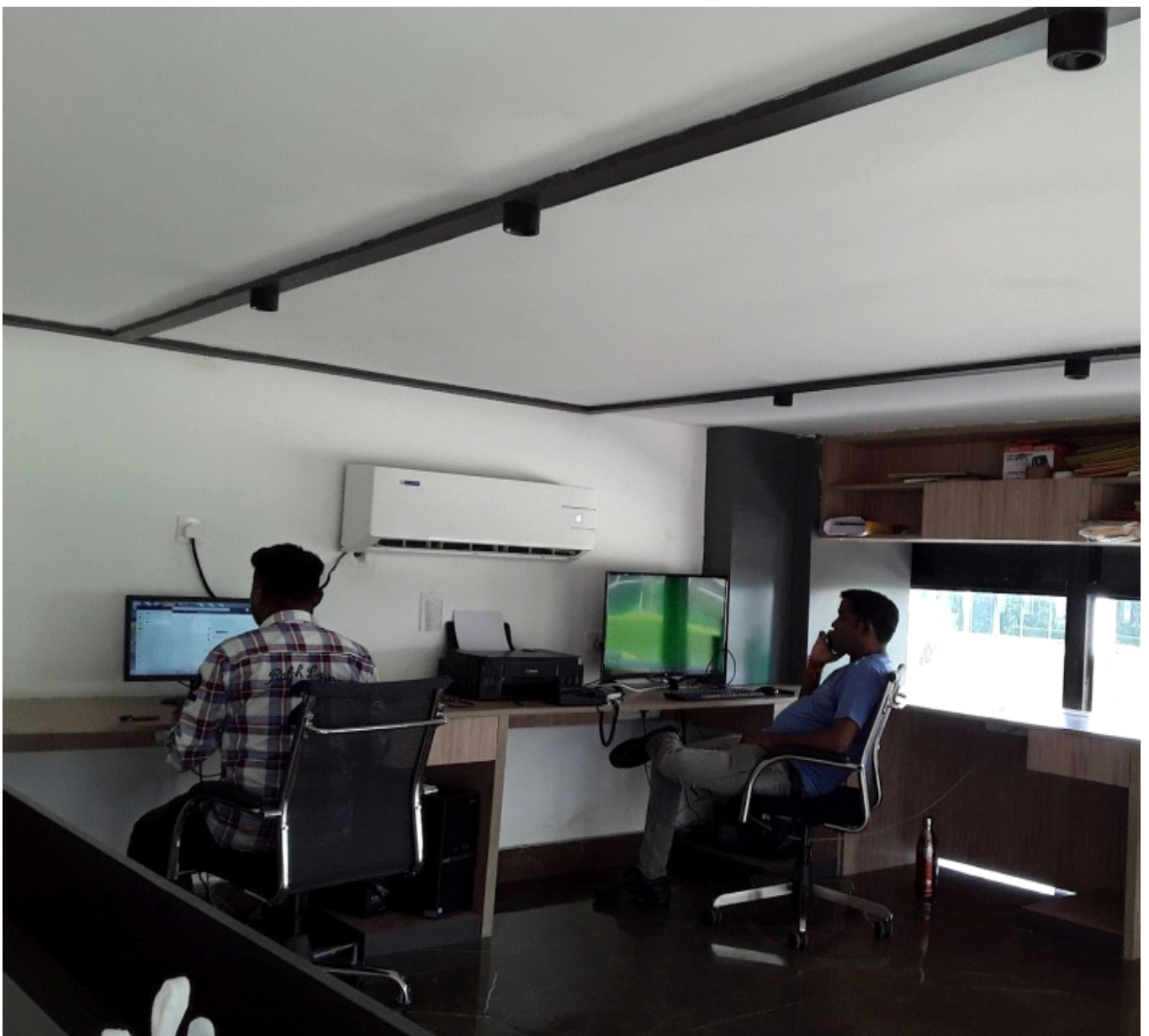
