#### Annexure

Kindly note the following very important point which need to be address for the continues of certification process.

- 1. DGFT Notification 73(RE-2013)/2009-2014, "A product will be allowed to be exported as "Organic Product" only when accompanied by a Transaction Certificate issued by a Certification Body before transaction organic product.
  - a. Organic certified exporters shall apply initially for issuance of a Provisional Transaction Certificate issued from Tracenet by an accredited certification body under NPOP before the consignment is shipped.
  - b. Export TC will be issued after submission of PTC documents with shipping documents.
- 2. Third party sampling and residual testing from APEDA approved ISO-17025 laboratory need to be done before export of organic product.
- 3. Before export of organic products, operator need to inform SGS for residual testing, label approval & Export TC.
- 4. The organic material must be identified in storage area during verification as per standard requirement.
- 5. The labels need to submit to SGS for review and further approval as per standard requirement before using on products.
- 6. The organic product reconciliation need to submit annually.
- 7. The renewal process of certificate must start from 90 days prior to certificate expiry date.
- 8. Need to visit APEDA website and TraceNet for regular updates.
- 9. An Additional inspection will be conducted for verification and approval of any changes in current certificate as per standard requirement.
- 10. Repacking is not allowed in Trading/ Handling certificate scope.
